Third Party Fundraiser application

Before event details are finalized, a Third Party fundraiser application must be completed, signed and returned to the Westchester Medical Center Foundation office.

Marketing and Promotion

Third Party fundraisers will receive hospital name and/or logo usage guidelines once application is approved. All publicity and promotional material referencing the involvement of Westchester Medical Center will require prior approval.

Event Expenses

The Third Party fundraiser is responsible for all event/activity expenses, including but not limited to: food, beverages, marketing, advertising, supplies, venue/permit fees and incidentals. Westchester Medical Center will not be responsible for any expenses or debts incurred.

Event Income

Only checks payable to Westchester Medical Center Foundation, Maria Fareri Children's Hospital Foundation or MidHudson Regional Hospital Fund will be provided with a tax deductible acknowledgment letter in accordance with IRS and state tax regulations.

Event Insurance and Liability

The Third Party fundraiser is responsible for obtaining any necessary permits and clearances required by local and state government and complying with all applicable laws. Sponsor must also obtain appropriate insurance coverage as necessary.

Tax Guidelines and Implications

The Third Party fundraiser is responsible for complying with all IRS regulations registrations applicable to the event. Federal tax laws disallow third-party events from using hospital foundation Sales Tax Exemption number or Federal Employer Identification number when purchasing any goods or services from suppliers or vendors.
